PUPPY CONTRACT

This agreement is made and entered into this ____ day of _____, 20__ by and between _____ (Seller) and _____ (Buyer), for the purpose of setting forth the terms and conditions of purchase by the Buyer of a purebred German Shepherd from the litter whelped on _____ out of Dam: _____ and Sire: _____ For _____ the seller agrees to sell and the buyer agrees to purchase a female _____, Male _____ companion puppy from the litter described above subject to the following terms.

1. Seller warrants that the above described puppy is a purebred German Shepherd Dog registrable with the American Kennel Club and that registration papers have _____ have not _____ been provided to the Buyer as of the date of the completed purchase.
2. Seller warrants that the above-described puppy is in good health at the time Buyer assumes ownership. Buyer agrees to have the puppy examined by a licensed Veterinarian with three (3) days (not including weekends and holidays) of receipt of puppy.
If, as a result of the examination, the Veterinarian determines that the puppy is not in good health then the Buyer shall elect to keep the puppy or return the puppy to the Seller for a refund. If the buyer elects to return the puppy, Buyer shall, within 10 days after the date of the signing of this contract, send to the Seller by certified mail a written Veterinarian's certificate stating that the puppy was in ill health when examined. Upon receipt by Seller of said certificate, Buyer shall be obligated to return the puppy to Sellers at Buyers expense. Upon receipt of the puppy, the Seller shall be obligated to refund all monies received from Buyer toward the purchase price of the puppy, and further performance under this contract shall be null and void. All action taken to return the puppy shall be done with the best interest of the puppy in mind.
3. Seller warrants that the puppy sold hereunder is progeny of dam and sire that was x-rayed and certified clear of hip and elbow dysplasia.
4. Ownership of the puppy will be transferred to the Buyer for the sale price of \$ _____ to be paid as follows: \$ _____ deposit on execution of the Agreement with the balance of \$ _____ to be paid on or before the puppy leaves the Sellers premises. If a check does not clear, this Agreement shall be cancelled and the Buyer forfeits the deposit given hereunder. In addition, the buyer must return puppy and registration to seller within one day after notice of a check not clearing or will be subjected to the filing of a police report and/or litigation by Seller. All deposits are non refundable at the signing of this contract, or receipt of money paid, unless it is the Seller that is backing out of sale.

5. The Seller has determined that the puppy is of “pet quality”. In such case, Seller shall provide Buyer with Limited Registration Certificate_____ or Full Registration with breeding rights_____.
6. Buyer agrees that the puppy will reside at the home of the Buyer, have access to a fenced yard, or be taken on at least a one mile on leash walk daily, not be chained or tethered, and will be provided with proper housing, a good quality diet, annual shots and exercise.
7. The seller at anytime before transference of puppy to its new owner, reserves the right to deny the sale of said puppy to its new owner with the deposit being refunded and the contract made null and void for any reason if it is deemed by the seller to not be in the best interest of the puppy.

This Agreement is made and signed by both parties to insure the well being and protection of this puppy. If the Buyer breaches any part of this Agreement, the Seller is released from any obligations under this Agreement.
